
Home Health Aide On-the-Go In-Service Lessons: Vol. 3, Issue 7: Patients with Multiple Sclerosis

LESSON OVERVIEW About 400,000 people in the United States have multiple sclerosis. The symptoms vary greatly from person to person and from time to time in one person. When symptoms are present, they often reduce the person s ability to perform activities of daily living (ADLs). During relapses, many patients with MS require assistance from home health aides. For that reason it is important that aides understand the basics of the disease as well as their role in providing care.
