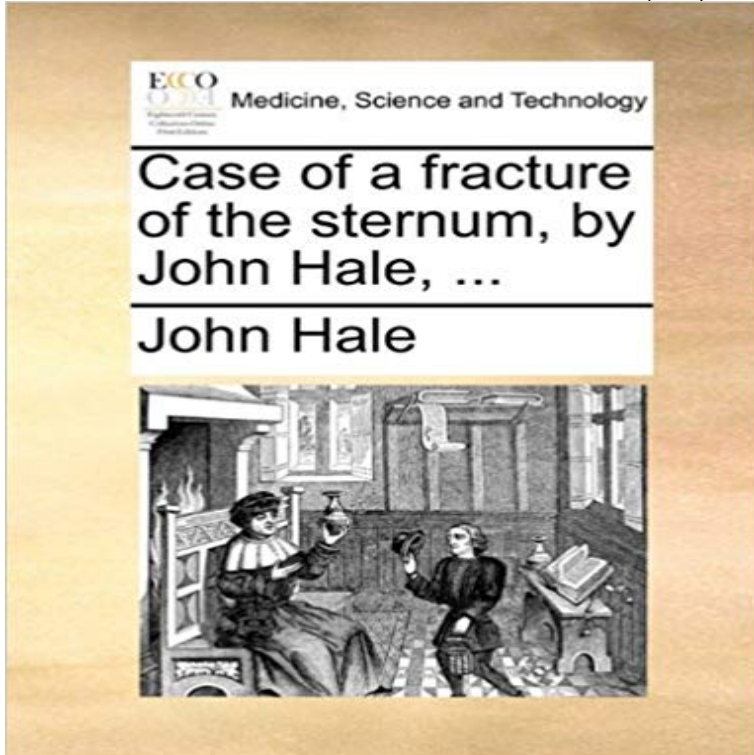


Case of a fracture of the sternum, by John Hale, ...
